Reservation Conditions

- * Allocation of stands: as the number of locations is limited, they will initially be allocated to exhibitors who were clients in 2008.
- * **The organiser reserves the right to refuse structures which could be detrimental to safety, or to the overall aesthetics of the event.**
- * Access to stands: stands will be available on **Monday 21 September 2009**.
- * Teardown: on Sunday 27 September after the competitions or on Monday 28 September 2009 at the latest.
- * Stands must be open to the public every day throughout the duration of the event.
- * **Sublease**: in return for the payment of an agreed price, subleasing is authorized by the organiser. It must be mentioned on the reservation form.

- * Exhibiting area:
 - * Stands are supplied with flooring by the organiser. The necessary extinguishers are supplied by the organiser.
 - * The dimension of the stands corresponds to the surface area rented.
 - * **Exhibiting goods outside the stands is strictly forbidden.**
 - * **The distribution of leaflets or the installation of banners on the different competition grounds or on advertising panels is forbidden unless written approval to do so has been given by the organiser.**
 - * The restocking of stands: the restocking of stands will be authorised twice a day: in the morning, before the competitions and in the evening after the competitions. **No vehicles will be authorized to move around on the site outside of these time slots. If this condition is not respected by the exhibitor it could result in him being excluded.**

- * Security: the site will be closed at night and our security company will carry out surveillance, but **the organiser will not be held responsible under any circumstances for thefts or for damage which occur to stands. It is each person's responsibility to ensure themselves against risks which may arise.**
 - * Parking: you will receive parking badges according to your exhibiting area and your personnel. For other vehicles, a free car park will be at your disposal.

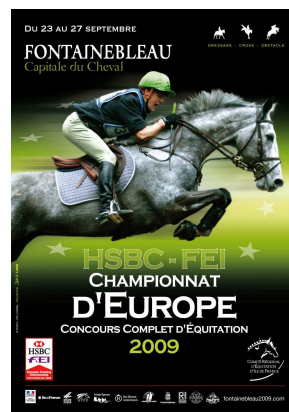
